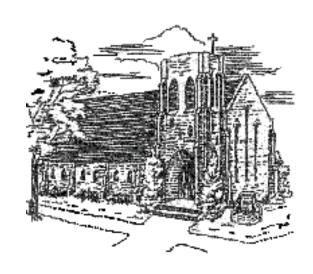

SENIOR WARDEN REPORT

Well, what a year it has been! We at Christ Church have gone through multiple changes which may seem challenging, unexpected, or unappreciated. I feel strongly that despite these changes and challenges, we are coming out on top! I am grateful for the support from fellow parishioners as we all work together to ensure that daily operations and services run smoothly.

I accepted the senior warden position after careful thought, feeling as if I did not have the know-how or qualities needed to do a good job. I thought that a one-year position would be possible and actually good for me to step out a little from my comfort zone. Little did I know that our rector, Fr. O'Flynn would retire resulting in a more challenging position for me. I will reiterate that I could not and do not do this alone. Many have stepped up to help in areas that are in need of daily attention, especially Pat Sylvia, as well as for those things I am not able to do because of my work. I thank all of you for your consistent support and the time you have freely given.

The pandemic also brought its difficulties: the learning curve of virtual services, providing safety when we are able to be in-person, and a new way offering communion. I am so appreciative of those who offered their technology expertise, especially John Bertram, and others for their ingenuity of the ins and outs of these varying services, especially Barb Myers, Peggy Stout, Nancy Faure, & Craig Hodges (I sincerely apologize to those whom I did not name). We are fortunate to have the support of our three supply priests, Father Bill, Canon Bradley, and Reverend Mikayla who are willing to preside over our services, whether in the church or at home.

Now for some announcements:

- 1. We have services covered through Easter by our supply priests. We will continue to be inperson as our COVID numbers stay low. Bishop Marty and her support staff maintain close Fr O'Flynncontact with all the diocesan churches. She will keep us updated as to the type of service that is allowed. She will also let us know when it is safe to reduce the precautions we have in place (masks, social distancing, etc) even if the state itself relaxes those safety measures.
- 2. The vestry will remain as is, that is to say 'frozen' for this next year. We look forward to the hiring of a new priest though each member of the vestry is willing to continue to serve until that time (or until the next annual meeting)
- 3. The vestry has voted to continue managing the donations for St. Nicholas School in Haiti. This will be done annually in September. Those wishing to make a donation, make sure it is clearly marked for St. Nicholas and the monies received will be sent out altogether. This is due to the high cost of getting the money to Haiti.

Again, thank you all for your support. We are all a team and a family and will get through this transition together as we have done in similar situations.

EUCHARISTIC MINISTERS/LECTORS/ACOLYTES

We have had a very unusual year for the Lectors, Eucharistic Ministers (Lay Readers) and Acolytes. For several weeks we did not have services due to the Covid 19 Pandemic. Then we had virtual services on U-Tube thanks to John Bertram. To avoid close contact we only had one Eucharistic Minister who did the duties of both EM and Acolyte. At this time we are having services in church practicing "social distancing". At present we have a total of 10 Lectors and 7 Eucharistic Ministers (Lay Readers). We have not been using the Lectors, the EM has been doing all the readings. The count for the active Acolytes is 5.

At present we do not have a permanent priest, so have not had any training on going.

If you are interested in becoming a Eucharistic Minister or Lector or Acolyte please talk with any member of the vestry or myself as we are always open to training new people. A good way to start, if interested in being a Eucharistic Minister is to be a Lector, especially if you are really not sure. Being a Lector, Acolyte or Eucharistic Minister is very rewarding and provides a wonderful ministry to Christ Church and our Lord Jesus Christ. We especially would welcome the young people to start as Torch Bearers as a precursor to being an Acolyte.

Hopefully soon we can get back to a "normal" service order and all can feel comfortable and safe in church.

Parish Music Report

This has been an interesting and unusual year of music-making at Christ Church!

During the calendar year, with the onset of Covid concerns and restrictions, much of what normally happens in the context of our liturgical music practices was severely curtailed. Because of the greatly heightened danger of spread through public singing, it was determined that our congregational singing would need to be put on hold. As disappointing as it has been not to be able to sing together as a congregation or a choir, it is good to know that the end is now in sight. When it will again be safe to engage with one another through the gift of music is not yet clear, but please know that we are planning and preparing for that day.

While we wait, with the great help and technical expertise of John Bertram, we have been able to live-stream preludes and hymn accompaniments provided by Meghan Hodges along with viewable pictures of hymn pages to enable those at home to sing together during the services.

We are blessed as a parish with a number of fine and dedicated volunteer musicians who have, each week, supported our congregational singing and provided beautiful musical offerings. Additionally, for special seasons, our regular church choir members have been joined by musicians from across the Valley as well as our own congregation for festival (Christmas and Easter) choirs. These folks have all expressed their desire to reconvene as soon as it is safe to do so.

Christ Church has also hosted for the past few years the monthly candlelit program of readings and a cappella medieval to modern choral music call *Nightcap for the Soul*, which has been attracting very large audiences. This musical program will again be up and running as soon as possible.

In the meantime, it has been good to focus on learning the many capabilities of our new organ and to find additional time to organize our choral score library in the Parish House music office.

Foundation Report 2020

The Christ Church Foundation's principal purpose is to provide a source of long-term operating income to Christ Church Parish. It holds and manages funds donated to it in an investment portfolio to generate income which is then donated to the Church and reinvested to increase the value of the endowment. The Foundation draws between 4% to 5% of the total value of the endowment each year to make regular monthly payments to the Church. The hope is that the performance of the portfolio exceeds what is drawn so that the total value continues to grow thus increasing the annual donation to the Church. When markets are rising such as last year, this is very successful. The Foundation board reviews and adjusts the donation amount each year in order to continue the income to the Church while still providing for the health of the endowment.

In January of 2020 the total value of the Foundation was \$341,309. Over the course of the year \$13,800 was donated to Christ Church as the regular monthly donation of \$1,150. The Foundation received a stock donation of \$61,362. It also facilitated another stock donation to the Church of \$20,449, these funds have been transferred to the Church. The total value of all accounts at the end of the year was \$413,389.

The Foundation has been looking at ways to invest in a socially responsible manner for a long time; however, there has not been a good way to do so. D. A. Davidson now offers a socially responsible portfolio, after watching it for a while we have decided to move part of our assets to this portfolio. We started with \$30,000 and then directed the donation we received to it so it now accounts for about a quarter of our investments. While it fits squarely in our mission there is concern that it may not offer the same return, and therefore ability to continue the donation to the Church at the same level. If it continues to perform well we will consider moving more of our assets to it.

During this time of transition, we realize that the monthly expenses of the Church are reduced without a priest salary to pay. We have decided to keep the contribution to the Church the same as last year at \$1,150 per month for at least the first 6 months. We also understand we may struggle to meet the additional costs of hiring a new Priest and pledge to increase our donation to \$1,500 a month once a priest is hired.

We are grateful to the many people who have donated to the Foundation over the years, and those who had the foresight to create it. The Foundation remains a great way to put your donation to work both for the immediate needs of the Church and for generations to come.

While tax changes may have decreased the tax incentive of charitable donations, there is still huge tax savings in gifting stocks to the Foundation or the Church. If you have a stock you bought for \$10 that is now worth \$100 you can gift it to the Foundation and avoid paying all of the capital gains taxes on the change in value. The Church would get the full \$100, and the

donor would get the full \$100 credit for the donation. But when the Foundation sells the stock it would not have to pay any taxes on the gains. We are setup up to easily receive and convert such donations to both the Foundation and the Church. We were excited to have received this type of donation this year.

Please continue to remember the Foundation in your financial planning. It allows your gifts to keep on giving.

Godly Play Report

Godly Play 2020 and its ministry to the children of Christ Church Episcopal is alive and thriving despite unexpected COVID-19 interventions. In January, we enjoyed an active group aged 5-12; class size ranged weekly from 6-10 children. We had just launched an ambitious, meaningful (and beautiful) Lenten art project, when meeting restrictions were adopted in March. So, our three teaching teams (Janelle and Hillary Willet, John and Susie Bertram, and David and Sharyn Curtis) began video-recording a new series of post-Easter lessons, which were then posted weekly on the church website.

By the time September came, we were prepared for a new approach to presenting lessons: we would adopt a new "curriculum" that could be presented remotely to children and their families, without sacrificing personal interaction: The Zoom Connection. We decided to use the book *Shepherd Stories*, (which David and Sharyn had originally written for children in the Czech Republic) as the basis for teaching and discussion. Each lesson contains a character-building story starring animal personalities, which is paired with a Bible story that follows the same theme (i.e., a wise owl named Onus and King Solomon). Now, Sharyn reads the stories remotely, and children attend either remotely from home or socially-distanced and masked downstairs at CCE. Each child has been provided his or her own copy of the book, plus crayons, markers, and a fabric book bag. Amazing discussions ensue every week, and interest seems to be high.

John Bertram summarized our Advent/Christmas event in this excerpt from a letter to the congregation:

"...for the Christmas Season. We were very inspired by the idea Jeannie (Fischer) shared of traveling advent guests. Traditionally during Advent, Godly Play has a connected series of stories that slowly builds the nativity scene and we hear stories of the different parts each week. This culminates in the live pageant on Christmas Eve. This year we are packaging up those stories and the figures from our Nativity, and will distribute them amongst the Godly Play families who will host a different part each week. Each traveler will leave behind an Advent candle at that house for their wreath. The families will be documenting the journeys with pictures, art and videos. We will then combine these pieces to create a digital pageant we will send to the congregation on Christmas Eve. We will also have a special gathering on Christmas Eve for just the Godly play families outside on a candle ringed labyrinth. Each family will get to walk the labyrinth and bring the figure they were hosting that week to the center to recreate the Nativity..." Everyone agrees that the whole experience was sacred and absolutely beautiful!

We enter 2021 with new hope, but with the sad realization that responsibilities have shifted, and John is needed in another area of service to our church family. His knowledge of videography, internet connection, tech support, etc., have proved to be invaluable as CCE grows into meeting a wider, more diverse audience. Godly Play will be needing another teaching team of two adults (a Godly Play safety requirement), who want to share the joy and responsibility of helping children grow into personal, dynamic faith in God. We have found that having three teams is perfect for providing continuity and stability for the children, while offering them fresh perspectives and different teaching styles. Three teams in rotation also allows respite for the teachers and divides the burden of responsibility. Please join us in praying and seeking the right people.

Bill Baumgarten, and Rev. Mikayla Dunfee. Rev. Mikayla led us in a successful Advent Quiet Day retreat via Zoom that was attended by 15 people.

In 2020, due to the COVID pandemic and at the direction of our Bishop, we shifted from in person worship at 8 and 10am, to one Morning Prayer service at 10am on "Go to Meeting", to Ante-Communion services on You Tube and website, to full Eucharist services on You Tube and website, and back to in person service at 10am with You Tube streaming available and website recording. Whew!! Makes me dizzy looking back. This fluid process has required that we meet more frequently; we have met once a month to plan and coordinate together. Our meetings have been held on the first Saturday of each month at 9am via Zoom and last one hour. Everyone is a member and is welcome. Our next meeting is February 6 at 9am.

Christ Church Episcopal Treasurer's Annual Report

For the Year Ended December 31, 2020

This report discusses CCE's financial performance for the year ended December 31, 2020. It includes two financial statements designed to provide an objective and easily readable analysis of CCE's financial performance for the year. Together these financial statements present the "big picture" of CCE's financial status and results of operations. Please read it in conjunction with all of the other reports contained in the Annual Report.

The Statement of Net Position presents information on all of CCE's assets (resources) and liabilities (debts), with differences between the two reported as *net position* (equity or worth). The Statement of Activities presents information for revenues, expenses, and the resulting change in net position for the year. Both statements report *net position* and how it has changed. Net position is the difference between CCE's assets and liabilities and is one way to measure CCE's financial health or *position*. Over time, increases or decreases in net position may serve as a useful indicator of whether the financial position of CCE is improving or deteriorating. To assess CCE's overall health, one needs to consider non-financial factors such as membership trends, vibrancy of the youth programs, outreach endeavors, and condition of the Church buildings and facilities. To this end I reiterate that this report is to be read in combination with all of the other ministry reports.

A fund is a grouping of related accounts used to maintain control over resources that have been segregated for specific activities or objectives. CCE maintains two types of funds. The Operating Fund (General Fund) is used to account for all of the normal operations of the CCE community. The Restricted Funds are used to account for non-operating activities such as the Red Door Pantry and Campus Ministry funds. Generally, the non-operating Funds are designated as restricted by contributors who stipulate that their contributions are to be used for specific purposes. The Vestry may also designate a portion of resources from the Operating Fund to be restricted for a specific purpose, such as a reserve account to pay for major building repairs and improvements.

The Operating Fund's net position increased by \$29,119 in 2020. This increase was offset by a decrease in the net position of the restricted funds of \$1,385 for the year. The decrease in restricted funds was largely due to decreases in the Building Reserve \$3,935, Mission \$1,813 Funds and increases in Worship \$2,987, Youth \$1,358. The overall net position of CCE increased \$27,734 to \$89,724 during 2020.

The Statement of Activities shows total revenues for the year of \$133,998, with \$124,024 (93%) in the Operating Fund and \$9,974 in restricted funds. Total revenue for 2020 was down \$3,887 from the previous year. Total expenses for the year decreased by \$31,214 to \$106,264 with \$94,969 (89%) incurred in the Operating Fund and \$11,295 (11%) incurred in the restricted funds. In total CCE ended the year with a \$27,734 surplus, which accounted for the increase in net position.

Operating revenues increased by \$18,310. Pledge and Plate revenue increased by \$10,526 (12%).

There was also a \$6,864 net decrease in operating expenses for 2020, largely due to a decrease in the Priest package expenses of \$9,720, General operating expenses of \$2,605 and an increase in Wages & salaries expenses of \$5,344. The Statement of Activities also shows that CCE passed \$11,295 through its restricted funds, including \$4,935 to the Building and \$4,022 to Pass Through accounts.

Finally, this report presents the 2021 operating budget adopted by CCE's Vestry. Budgeted revenues for 2021 have been set at \$107,900, and remain the same as 2020. Budgeted expenses for 2021 have been set at \$106,656, a decrease of \$6,944 over the prior year. The decrease in budgeted expenses is mainly the result of an decrease in the Priest package during the search for a new priest. During 2020 as a result of the CARES Act, Christ Church received a PPP loan in the amount of \$11,791 for payroll expenses. This amount has been forgiven and is included in the revenue figures for 2020.
